# APPLICATION FOR ACCREDITATION DIRECTIVE

**1. Article: Basis, Purpose, and Scope**

- 1.1. This directive has been prepared in accordance with the Working Regulations of the STAR Social and Human Sciences Accreditation and Rating Association.
- 1.2. The purpose of this directive is to regulate the Accreditation Application Petition and Accreditation Application Information that must be submitted by the Rectorate or Faculty Administration on behalf of the Higher Education Institution applying for accreditation.

**2. Article: The Petition of Application for Accreditation**

- 2.1. The Accreditation Application Petition, provided in the annex of this directive, must be submitted to STARA.

**3. Article: Accreditation Application Information**

- 3.1. The Accreditation Application Information must be submitted to STARA.

**3.2. General Information:**

1. Higher Education Institution administering the Undergraduate Program
2. Faculty administering the Undergraduate Program
3. Department administering the Undergraduate Program
4. Administrators of the Rectorate, Faculty, and Department, including:
  - a. Academic titles
  - b. Full names
  - c. Mobile phone numbers
  - d. Email addresses
  - e. Mailing addresses
5. If multiple undergraduate programs are applying for accreditation, the designated faculty member (coordinator) appointed by the Dean's Office to ensure coordination among the programs.

**3.3. Information Regarding the Undergraduate Program:**

1. Name of the Undergraduate Program
2. Designation on the diploma awarded to graduates
3. (If applicable) Changes in the designation on the diploma
4. Language of instruction of the Undergraduate Program
5. Year the Undergraduate Program first admitted students
6. Year the Undergraduate Program awarded its first graduates
7. Number of graduates over the last five years

**4. Article: Applicable Evaluation Criteria**

4.1. The Evaluation Criteria published on the official website [www.star.org.tr](http://www.star.org.tr) must be used for undergraduate programs applying for accreditation.

**5. Article: Contact Address**

5.1. The Accreditation Application Petition and Accreditation Application Information must be submitted via email to [starak@star.org.tr](mailto:starak@star.org.tr).

**6. Article: Amendments to the Directive**

6.1. This directive is reviewed by the STAR Board of Directors.

**7. Article: Enforcement**

7.1. This directive enters into force on the date of approval by the STAR Board of Directors.
